**IMPORTANT - TRANSFER** of dogs from regular classes to Best of Breed/Variety Competition (Ch. 11 Section 6, AKC Rules) MUST be made to the Superintendent/Show Secretary at least one half hour prior to the start of any regular conformation judging at this show. TRANSFERS by Junior Handlers from Novice to Open Class MUST be made to the Superintendent/Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show. SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the judging of any Junior Showmanship classes at the show. MOVE UP OF DOGS IN OBEDIENCE/RALLY CLASSES (Ch. 1 Section 16 of Obedience Regulations) The request for a move up must be in writing and presented to the Superintendent/Trial Secretary at least 30 minutes prior to the start of each trial. Move ups for Obedience may be approved, provided the next level class and judge are available and the class has not reached its limit.

**Directions to the Emergency Veterinary Clinic:** Follow race track around to the stable side until you get to an exit. That exit is Rt. 188. Make a right hand turn onto Rt. 188 East. Follow 188 for 2.1 miles. Braden Run Animal Hospital has a large sign on the right side of the road. Turn left immediately following the sign. That is Braden Run Road. Follow it for 0.6 mile. The animal hospital is on your left.

**The Club President, Show Chairperson, Assistant Show Chairman, Obedience & Rally Chairperson, Hospitality Committee and members of their family will not show dogs or have dogs shown which are owned or co-owned by them as a courtesy to our exhibitors.**

**Ramps at the sole discretion of the judge,** approved breeds may be examined on the ground or on a ramp: Clumber Spaniels, Sussex Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden & Polish Lowland Sheepdogs. (Whippets may be examined on the ground, on a table or on a ramp.)

**Basset Hounds** are expected to be judged on ramp during breed judging.

**This list may be revised** from time to time, and the current list can be found on the AKC website in Judging Operations. **A judge requesting** the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required.

**Ramps may be used** in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

### NOTICE

### NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

**Dogs May Arrive** any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

**Judges Will Not Wait for Any Dog Holding Up a Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

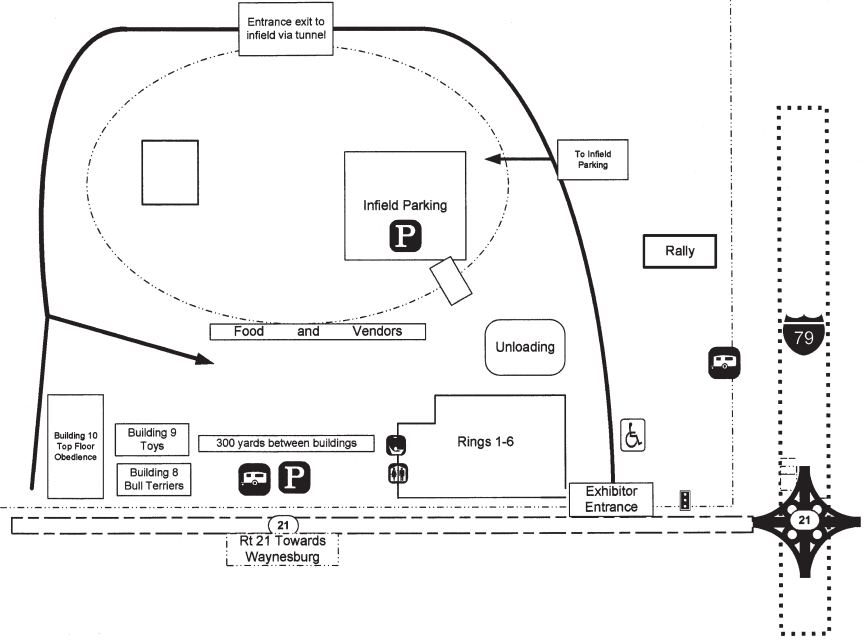
## GENERAL PARKING
