SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the judging of any Junior Showmanship classes at the show. MOVE UP OF DOGS IN OBEDIENCE/RALLY CLASSES (Ch. 1 Section 16 of Obedience Regulations) The request for a move up must be in writing and presented to the Superintendent/Trial Secretary at least 30 minutes prior to the start of each trial. Move ups for Obedience may be approved, provided the next level class and judge are available and the class has not reached its limit.

A new Exhibitor Briefing will be held in Ring 1 at 12:30 PM. Spectators are welcome to attend.

Ramps at the sole discretion of the judge, approved breeds may be examined on the ground or on a ramp: Clumber Spaniels, Sussex Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden & Polish Lowland Sheepdogs. (Whippets may be examined on the ground, on a table or on a ramp.)

Basset Hounds are expected to be judged on ramp during breed judging.

This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations. **A judge requesting** the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required.

Ramps may be used in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

NOTICE

JUNIORS WHO SUBSTITUTE FOR THE ORIGINAL DOG THEY HAVE ENTERED IN THE JUNIOR SHOWMANSHIP CLASSES WITH DOGS THAT ARE NOT ENTERED IN ONE OF THE OFFERED CLASSES AT THIS SHOW MUST REMIT THE JUNIOR SHOWMANSHIP ONLY ENTRY FEE WITH THEIR SUBSTITUTION.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

Dogs May Arrive any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused. Judges Will Not Wait for Any Dog Holding Up a Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

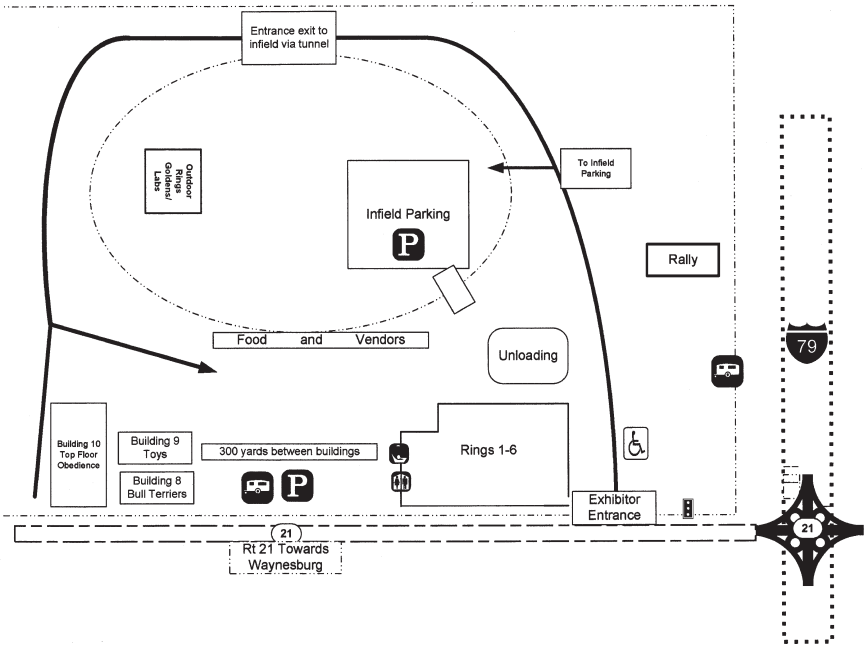
All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring. **No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

GENERAL PARKING

Parking fees: **\$3.00 per vehicle, per day or \$10.00 for all four days.** For your convenience, parking attendants will assist and direct parking. Cooperation with all parking attendants including following instructions and directions is required. Failure to do so may result in the withdrawal of your parking privileges on the grounds for the show. Illegally parked vehicles will be towed at the owner's expense.
